The Greater Cincinnati Garden Railway Society is presenting a trip to the Age of Steam Round house in Sugar Creek, OH on September 12, 2015 by bus as a group. **There will not be any private vehicles allowed, no exceptions.** We are limited to 45 for the trip. Cost: **\$75.00** - Includes Bus, Buffet Lunch at Berlin Farmstead Restaurant
Entrance to A of Steam Roundhouse, water on the bus and gratuities.
Leave: **EnterTRAINment Junction: 7379 Squire Court West Chester**
at 7:00 AM - Parking in the north Parking lot by I-75.
Time: Bus will start loading at 7:00 am with **Departure at 7:10 am at the latest.**
Return: Expected to arrive back at EJ before 7:00 PM
Clothing: Wear **old clothing** as you will be in a work area that is dirty and oily.
Shoes: **No high heels, no open-toed shoes, no sandals, no beach flip-flops. No exceptions.**
Releases: You will have to **sign the appropriate release** to enter the Age of Steam to be provided on the bus.
Snacks: Please **bring your own snacks for the day.** Water only will be provided.

GCGRS general information for September 12, 2015

Before scheduling your tour of the Age of Steam Roundhouse...

Please review all of the notes below. Then fill out the releases needed and bring along with you. They will be collected on the bus for turn in to the Age of Steam staff.

1. Saturday, September 12, 2015 Leave EJ at 7:10 am Eat 11:30 am Tour 1:00 pm Leave 2:30 pm
2. Your group's members may make for their own personal use photos and videos during their tour of the AoSRH facilities. However, **we prohibit the distribution or publication of photos depicting the AoSRH that your members make here during their tour.** This is also spelled-out on the liability releases that your members will sign. We do not want members of your group to post onto the Internet or social network their AoSRH tour images, because we then get hundreds of individual, non-group requests for tours and/or open visitation. Since we are not open to the public we can't handle open visitation and want to discourage all such notions that AoSRH is open. **We do permit the use of such tour photos in your group's newsletter.**

3. GCGRS has set the group size to 45 for this trip.

As of now, there are legal and insurance reasons why there is no open visitation and why all tours must be guided. A tour group larger than about 40-50 people makes hearing the speaker more difficult for people in the back of the group. Some areas of the property will be strictly off-limits, such as outside storage tracks and other areas designated as being "off-limits" with yellow safety tape.

4. Before arriving at the Age of Steam Roundhouse each tour-taker will be required to fill out a liability release (attached) for him- or herself, and for those custodial parents and/or legal guardians to fill out for their minor children. Grandparents and other relatives who are NOT custodial parents/legal guardians have no legal authority to sign such releases for any non-custody children— even though Gramps signed a paper, the kids' custodial parents or legal guardians could still sue AoSRH. No exceptions. Before your group's members enter onto AoSRH property, this legal paperwork must be completed so that it can be handed to an AoSRH employee at the front gate for quick admission to the property and roundhouse.

5. We do not permit children under the age of 12 to be part of railfan group tours.

6. **Visitors to the Age of Steam Roundhouse need to pay attention to their footwear. No high heels, no open-toed shoes, no sandals, no beach flip-flops. No exceptions.**

7. Public ADA restrooms are available on site

8. There will be a charge of \$20.00 per person taking the tour. This is paid in your trip fair to the GCGRS.

9. The Bus will drop us off at the roundhouse entrance door and then in the lot.

10. Visitors in wheelchairs or with walkers should have no problem moving around on the flat, concrete floors inside and outside of the Age of Steam Roundhouse and shop buildings.

11. Railroad cars, locomotives and their work areas can be dirty, greasy and oily, so, just in case you brush-up against some genuine railroad grime and might ruin your new shirt, it is **strongly suggested that you wear old clothes during your tour.** Repair work will not be taking place during your visit, so you need not worry about sparks, smoke or loud noises.

12. The easiest way to get to the Age of Steam Roundhouse is from the Route 39/Route 93 intersection on the west side of Sugarcreek. Go south on Route 93 for 3 miles, and at the Cabin Creek Golf Range (on your left) turn left off Route 93 and go ¾-mile. The AoSRH will be on your right—you can't miss it. Coming north up Route 93 from Baltic, go ¾-mile past the railroad crossing and turn right at Cabin Creek Golf. Go ¾-mile, and the AoSRH will be on your right—you can't miss it. If you are using a GPS locator, type in "213 Smokey Lane Sugarcreek, Ohio," and the Age of Steam Roundhouse will be clearly visible.
